Standing Rules Arena Use Information

1. Arena use fees are optional and are solely to allow access to the facilities at any time other than formal events. Upon receipt of the arena use fee, the registrant will be provided with the lock codes to the arena gates and equipment storage. It is expected that, after use, gates will be locked, and equipment will be properly put away and locked. Any member or family found in violation will be subject to having their membership and arena use revoked.
2. Arena use fees are for the period of April to April in any given year.
3. The amount of the arena use fee is \$50 per individual or \$75 per immediate family per season. Anyone 18 years of age or over on any arena use fee may use the facilities at any time when they are not being used for a scheduled event. Any agent(trainer) that wants to use the arena for lessons or show practice needs to pay for an annual arena use and all their clients need to pay for annual arena use. Any group, other than a family, that is interested in an annual arena use should contact the BFSC board via bfscsummerseries@gmail.com with a description of the group for board review and determination of charges. No one under the age of 18 is permitted to use the arena unless a parent, guardian or designated agent is present at all times. Considering the risk of equestrian activities, it is recommended that no one ride alone at BFSC facilities.
4. If any member or family or group desires to have exclusive access, a separate booking and fee will be required. Please contact bfscsummerseries@gmail.com with requested date(s) and description of event for booking. Any decision made by the Board will be final.
5. Due to high demand, arena use on the Friday before a scheduled show will be on a scheduled time basis(no more than a two hour window) and reservations must be made through the BFSC board via bfscsummerseries@gmail.com
